All payments are in HRK as per EUR selling exchange rate of the Privredna banka Zagreb on the invoice date, governed by EUR rate on the payment date.

Invoices are payables within seven days as of their issuance. For each late payment, the exhibitor shall pay legal default interests.

This Application Form is a Contract and from the date of both parties signature the same obliges each party to the execution of commitments.

## FAIR RULES

All individuals and companies that have correctly filled out, certified and submitted the Application Form may participate in the Fair, provided they have fulfilled the obligations under these Rules.

In case of violation of positive legislation RH by Exhibitor sanction for these offenses and penalties shall be bore solely by the Exhibitor.

If the Exhibitor is obliged for fiscalization, Exhibitor is obliged to comply with these regulations, and exclusively responsible for non-compliance of the same.

If Exhibitor sells products that require a sanitary and other permits (on product safety, etc.), must obtain permits independently and is responsible for any omissions and bears penalties for not having them.

### APPLICATION

The Application is irrevocable and binding for the Exhibitor. If the Exhibitor withdraws the Application in writing due to unpredictable circumstances at latest 60 days prior to the start of the Fair and the Organizer accepts it, the exhibition area will not be invoiced to the Exhibitor.

Exhibitor cancellation within 60 days or less from the beginning of the Fair, 50% of ordered exhibition area and services will be invoiced to the Exhibitor. The Organizer cannot accept the withdrawal within 30 days or less prior to the start of the Fair, and the entire ordered exhibition area and services will be invoiced to the Exhibitor. The organizer reserves the right to change the location of the fair.

### PAYMENT CONDITIONS

Following the receipt of the Application Form, and at latest after the final Application deadline, the Organizer shall make an invoice payable within 7(seven) days by bank transfer.

### EXHIBITION AREA

The minimum exhibition area that can be ordered is 12 sqm, and maximum is 80 sqm. The Exhibitor is not allowed to lease the exhibition area to a third party without the Organizer's approval. The Exhibitor is obliged to finish all construction works 12 hours prior to the start of a fair, and all the arranging 6 hours prior to beginning of the fair.

### DISCOUNTS

The Organizer provides 2% discount for 32 sqm to 47 sqm of ordered exhibition area, 4% for 48 sqm to 80 sqm. Discounts are applied only for exhibition area. Discounts are not provided for possible arrangements of the stands (for barter deals among the parties, which can be realized exclusively prior to the start of the Fair).

### FAIR CATALOGUE

The Organizer publishes a catalogue with the list of participants, products and services, and advertisement messages. The Exhibitor's entry in the catalogue is mandatory, and the data to be entered into the catalogue must be provided by the Exhibitor together with the Application Form and the Exhibitor is responsible for their accuracy. If the Exhibitor fails to provide the requested data for the catalogue until the final deadline for Application, only the basic general data of the Exhibitor available to the Organizer will be published.

### INSURANCE

Contracting of the insurance of the fairgrounds is the Organizer's obligation. Insurance of the exhibits is under Exhibitor's obligation through Insurance company. Insurance is valid during working hours of the fair.

### HEREWITH WE CONFIRM OUR PARTICIPATION IN THE FAIR AND ACCEPTANCE OF ALL THE ORGANIZER'S CONDITIONS AND PRICES AND WE UNDERTAKE AS FOLLOWS:

- 1) We will submit the Application Form with the complete requested documents to the Organizer prior to the Fair;
- 2) We will make the full payment to the Organizer's bank account within the term stipulated by the Organizer, at latest 7 days till the beginning of the fair;
- 3) If the Exhibitor fails to meet its liabilities to the Organizer, the Exhibitor herewith agrees that neither official nor unofficial contractor can start with the arrangement works of the exhibiting area at the Fair;
- 4) The Exhibitor undertakes not to leave the fairgrounds without the verified exit certificate issued by the Organizer;
- 5) In case of a dispute, a competent court in Split shall have jurisdiction;
- 6) The Organizer is allowed to take pictures and audio-video materials during the preparations, fair and after the fair with no agreement or special authorization and use materials for its own promotion.
